Elections—We are seeking much needed help. Our Treasurer, Mike Fortunato is seeking retirement. Mike would like to train the new volunteer, to have a smooth and painless transfer of duty. Our RSO, Mark Rosenbach, has indicated due to work and home environment changes, Mark can no longer devote the time to perform these duties. Trap Range—Our landscaper told us that during last property service, there was an equipment failure with the weed killer sprayers. A large portion of the grass on the trap range will perish in the coming days. The landscaper will repair the damage.

Membership Outsourcing — We have a very mature Membership software system supporting our organization. This software is no longer supported by the vendor, and there is no upgrade path. We have reached a critical point with this system. **Vince M.** is already working about 70 hours a month doing membership with this present system. I (**Rich**) have used this system and it is difficult to use. **Vince** has no additional volunteer hours to commit to transferring our membership database to a new system. **Vince** submitted a proposal to have the membership database transferred to a newer system done by an outside firm. This outside firm will be an LLC run by **Vince** himself, with the ability to have some of the efforts delegated to additional personnel
