SOPS FOR TRIP SHOOTING

1-SHOOT MANAGEMENT MAY DISQUALIFY A SHOOTER FOR VIOLATION OF THESE RULES.

- 2- IT IS SHOOT MANAGEMENT'S RESPONSIBILITY TO REMOVE ANY PERSON WHO IS CONDUCTING HIMSELF/HERSELF IN AN UNSAFE MANNER.
- 3- IT IS SHOOT MANNAGEMENT'S RESPONSIBILITY TO INSTRUCT THE TRAP HELP IN THE PROPER AND SAFE CONDUCT OF THEIR RESPECTIVE DUTIES.
- 4- A WARNING DEVICE WILL BE PALACED ON ROOF OF TRAP HOUSE BEFORE EXITING.
- 5- TRAP PERSONNEL WILL BE THOROUGHLY INSTRUCTED OF THE POTENTIAL DANGER OF THE TRAP THROWING ARM.
- 6- THE PRACTICE OF TRACKING TARGETS BEHIND A SHOOTING SQUAD IS UNSAFE, DISCONCERTING TO THE SHOOTERS, AND IS NOT PERMITTED.

- 7- IF ANY SHOOTER IS SUSPECTED OF UNDER THE INFLUENCE OF ALCOHOLAND OR/DRUGS THEY WILL BE REMOVED IMMEDIATELY FROM THE RANGE.
- 8- A GUN WHICH FOR ANY REASON FAILS TO FIRE AS INTENDED MUST BE PROMPTLY OPENED WITHOUT ANY SUBSEQUENT DETERMINATION BY THE REFEREE/SCORER OF THE CAUSE OF FAILURE TO FIRE.
- 9- ALL GUNS MUST HAVE THE ACTION OPENED AND CONTAIN NO LIVE OR EMPTY SHELLS AT ANY TIME, EXCEPT WHILE THE SHOOTER IS ON THE FIRING LINE. A BREAK OPEN GUN'S ACTION MAY BE CLOSED WHEN IT IS IN A GUN RACK BUT IT SHALL NOT CONTAIN A LIVE OR EMPTY SHELL.WHEN THE GUN IS REMOVED FROM THE RACK ACTION WILL BE OPENED.
- 10- AS A SAFTY PRECAUTION, TEST SHOTS WILL NOT BE PERMITTED UNDER ANY CIRCUMSTANCE.
- 11- A SHOOTER SHALL PLACE A LIVE SHELL IN HIS/HER GUN ONLY WHEN ON A POST FACING THE TRAPS.IN SINGLES AND HANDICAP SHOOTING HE/SHE MAY PLACE ONLY ONE (1) LIVE SHELL IN HIS/HER GUN AT A TIME AND MUST REMOVE IT OR THE EMPTY SHELL(S)

- 12- SNAP CAPS OR RECOIL REDUCTION
 DEVISE'S MAY BE EXCLUDED FROM THE
 ABOVE ONLY IF COLORED A SAFTY ORANGE AS
 TO PERMANENTLY IDENTIFY THEM AS NOT
 BEING A LIVE OR EMPTY SHELL.
- 13- IN CHANGING FROM ONE (1) POST TO ANOTHER, THE SHOOTER SHALL NOT WALK IN FRONT OF THE OTHER COMPETITORS.
- 14- A SHOOTER MAY HOLD HIS/HER GUN IN ANY POSITIONAS LONG AS IT IS POINTED DOWN RANGE WHEN IT IS HIS/HER TURN TO SHOOT. THE SHOOTER MUST IN NO MANNER INTERFERE WITH THE PRECEDING SHOOTER BY RAISING HIS/HER GUN TO POINT OR OTHERWISE CREATE AN OBSERVABLE DISTRACTION.
- 15- ALL GUNS USED BY SHOOTERS MUST BE EQUIPPED SO AS NOT TO EJECT EMPTY SHELLS IN A MANNER THAT DISTURBS OR INTERFERES WITH OTHER SHOOTERS.
- 16- ALL PERSONS INCLUDING SHOOTERS, SCORERS, AND TRAP PERSONNEL MUST WEAR APPROPRIATE EYE AND HEARING PROTECTION WHILE ON THE TRAP FIELD. FAILURE TO

COMPLY YOU WILL BE ASKED TO LEAVE THE TRAP RANGE.

- 17- A SHOOTER CANNOT USE: A GUN LARGER THEN 12 GAUGE. LOADS THAT CONTAIN NICKEL OR COPPER COATED SHOT OR TRACER LOADS.HOWEVER; THE USE OF LEAD, BISMUTH, OR OTHER COMPOSITE NONTOXIC SHOT MATERIALS SHALL BE ALLOWED.
- 18- ANY LOAD WITH A VELOCITY GREATER THAN 1290 FPS WITH MAXIMUM SHOT CHARGE OF 1 1/8 OUNCES OR 1325 FPS WITH A MAXIMUM SHOT CHARGE OF 7/8 OUNCES AS MEASURED IN ANY INDIVIDUAL SHOTSHELL. THESE VELOCITIES ARE MAXIMUM AND NO INDIVIDUAL SHOTSHELL SHALL EXCEED THESE LIMITS FOR THE DESIGNATED SHOT CHARGE. IN ADDITION, NO LOAD CONTAINING MORE YHAN 1 1/8 OUNCES OR ANY SHOT LARGER THAN 7 1/2 CAN BE USED.
- **20-** THERE WILL BE NO HANDLING OR POINTING OF GUNS BEHIND THE LINE.
